Dear Applicant:

The Fish Creek Harbor Commission made the following change in policy at the September 11, 2007 meeting.

- As of January 1, 2008 a deposit would be required for individuals on the slip and/or mooring waiting list.
- Slip deposit \$500
- Mooring deposit \$200
- Deposits will be refundable and held in a non-interest bearing account
- Deposits are one time only
- Annual reapplication is unnecessary; annually points will be added based on the latest application on file.

If you wish to be on the slip and/or mooring waiting list, remit the required deposit with your application to the Town of Gibraltar, PO Box 850, Fish Creek, WI 54212. If you have any questions, contact the Town Office at (920) 868-1714.
